CALL TO ORDER

The meeting was called to order by Chair, Fred Lewis, at 10:00 a.m.

OPEN PUBLIC COMMENT FOR DISCUSSION OF THE SPECIAL ASSESSMENT DISTRICT

The Public Hearing was opened for public discussion by Chair, Fred Lewis.

PUBLIC COMMENT

Unknown: Question was asked about Mudd Lake getting the purple loosestrife weed into Loon Lake. Fred Lewis says that the weed actually came from Loon Lake to Mudd Lake. Unknown person asked about using insects to control. Fred Lewis answered, as a rule bugs can't be controlled. Can't guarantee the bugs will stay where they are placed or not die. Purple loosestrife weeds can be controlled through PLM.

Unknown: Question was asked about the decline in Walleye fishing. Casey from PLM answered PLM priority is weed control, DNR Fisheries and EGLE have specific rules in place to prevent harm to Loons's and fish. PLM is only allowed to go 100 feet from shoreline and we don't treat undeveloped areas of the Lake.
